**DEFAULT JUDGMENT AGAINST
DEFENDANTS BOYD LEE
CODDINGTON, JR. AND GENUINE
BOYD'S LLC**

Defendants/Counterclaim Plaintiffs GENUINE BOYD'S LLC and BOYD LEE CODDINGTON, JR.'s Answer, Affirmative Defenses, and Counterclaims (Dkt. 6) having been stricken by this Court on March 7, 2012, (Dkt. 49), and default having thereto been entered; upon application of Plaintiff/Counterclaim Defendant SAEMIE CORPORATION ("Plaintiff") (Dkt. 50), and upon considering the moving papers and evidence presented by Plaintiff on March 13, 2012, as well as Plaintiff's Request for Attorneys' Fees Pursuant to Default Judgment and the declarations and evidence in support thereof, (Dkts. 53, 57) it is hereby ORDERED, ADJUDGED, and DECREED that:

1. As to Plaintiff's claim for breach of contract against Defendant BOYD

1 LEE CODDINGTON, JR., Plaintiff shall recover of Defendant BOYD LEE
2 CODDINGTON, JR., the sum of \$133,042.13, plus costs and interest according to law
3 from the date of this judgment until the entire amount is paid;

4 2. As to Plaintiff's claim for breach of contract against Defendant
5 GENUINE BOYD'S LLC, Plaintiff shall recover of Defendant GENUINE BOYD'S LLC,
6 the sum of \$133,042.13, plus costs and interest according to the law from the date of this
7 judgment until the entire amount is paid. The sum of \$133,042.13, for this claim is the
8 same—not cumulative—as those for Plaintiff's breach of contract claim against
9 Defendant BOYD LEE CODDINGTON, JR., in the sum of \$133,042.13;

10 3. As to Plaintiff's claim for breach of fiduciary duty against Defendant
11 BOYD LEE CODDINGTON, JR., Plaintiff shall recover of Defendant BOYD LEE
12 CODDINGTON, JR., the sum of \$33,884.92, plus costs and interest according to law
13 from the date of this judgment until the entire amount is paid;

14 4. As to Plaintiff's claim for fraud and deceit against Defendant BOYD LEE
15 CODDINGTON, JR., Plaintiff shall recover of Defendant BOYD LEE CODDINGTON,
16 JR., the sum of \$119,919.54, plus costs and interest according to law from the date of this
17 judgment until the entire amount is paid;

18 5. As to Plaintiff's request for attorneys' fees against Defendants BOYD
19 LEE CODDINGTON, JR. and GENUINE BOYD'S LLC, Plaintiff shall recover of
20 Defendants BOYD LEE CODDINGTON, JR., and GENUINE BOYD'S LLC, jointly and
21 severally, the sum of \$95,465.60, in attorneys' fees and \$4,768.68, in costs, plus costs and
22 interest according to law from the date of this judgment until the entire amount is paid;

1 6. As to Plaintiff's request for an accounting of the revenues, profits,
2 expenses, costs, accounts receivables, and other financial figures and information from
3 Defendant BOYD LEE CODDINGTON, JR., regarding FORGED RIM SUPPLY, LLC,
4 Plaintiff's request is GRANTED.

6 Federal Rules of Civil Procedure.
